Abstract:	The American Scenic and Historic Preservation Society was founded in 1895 to preserve scenic and historic sites. The records contain correspondence, minutes, reports, photographs and printed material documenting the Society's work, chiefly in New York State.

Historical note

The American Scenic and Historic Preservation Society (ASHPS), originally called the Society for the Preservation of Scenic and Historic Places and Objects, was founded in 1895 by Andrew Haswell Green (1820-1903), New York City civic leader and conservationist. Active largely in New York State, with headquarters in New York City, the Society's purpose was to protect scenic and historic sites. Its chief method was to act as custodian for scenic areas and historic sites, acquiring them, maintaining them, and keeping them open to the public free of charge. Such sites included John Boyd Thatcher Park, near Albany; Battle Island Park, between Fulton and Oswego; Stony Point Battlefield REservation, on the Hudson; Fort Brewerton, on the Oswego River; Letchworth Park, on the Genessee River; Watkins Glen, near Seneca Lake; Philipse Manor Hall, Yonkers; Hamilton Grange, Nw York City; and John William Draper Memorial Park, Hastings-on-Hudson. Some of these sites, all of which were located in New York State, were eventually put into the care of the state or federal government.

In addition, the Society worked on behalf of numerous sites not specifically under its care, supporting or opposing legislation; working on behalf of endangered sites; acting as an advisor; working for the improvement of cities through the protection of parks and historica buildings and districts; erecting monuments and plaques; helping to establish parks; and pushing for the creation of the New York State Conservation Department. While most of this concerned sites in New York State, the Society was also active on behalf of sites throughout the United States and in Europe. Some sites that benefitted from these efforts include: Niagara Falls; Palisades Interstate Park; the Octagon House, Washington, D.C.; Storm King Mountian in the Hudson Highlands, where Consolidated Edison planned to build a power plant; Washington Square, Inwood Park, Fort Washington, Fraunces Tavern, and the Morris-Jumel Mansion, all in New York City; reconstruction efforts in France after World War I; cemeteries in France for American soldiers, following World War I; and many others.

Presidents of the Society included Andrew H. Green, Walter S. Logan, George Frederick Kunz, George McAneny, and Maj. Gen. Alexander Hamilton.

Series II. Record Books, 1898-1926

Nine boxes.

The series consists of seventeen record books, numbered one through eighteen. There is no gap in the records although volume 18 is missing. The volumes contain minutes of trustees' monthly meetings, annual meetings, and meetings of various committees; lists of officers and trustees; by-laws and charters; correspondence of secretaries and presidents (including the founder and first president, Andrew H. Green); reports; New York State legislative documents; clippings; circulars; brochures; dues and membership forms; blueprints, maps, photographs showing scenic and historic sites with which the Society was concerned; and accounts. These elate to the administration of sites under the Society's custodianship, sites not under its custodianship, but with which it was concerned, and a wide variety of other Society matters.

Series III. Committee Records, 1900-1939

Four boxes

Committees were charged with the oversight of the administration of scenic and historic sites for which the Society was acting as custodian. Records consists of committee minutes; monthly reports form park directors, superintendents, or caretakers; and related correspondence, photographs, maps, blueprints, visitor statistics, legal documents, and printed material. Generally, these relate to the maintenance and operation of the sites and, to a lesser extent, to the acquisition of sites. Some records from other, similar, committees can be found scattered throughout the collection.

Series VI. Financial Records, 1895-1919; 1930s-1960s Four boxes

This series contains auditors' reports, drafts of financial statements, ca. 1959-1960s; and miscellaneous correspondence, accounts, notes, tax documents, bills, and invoices, ca. 1930s-1960s. These relate to contributions to the Society, purchases made by and from the Society, taxes, city and federal tax-exempt status, and general financial matters. Two mailing books, listing recipients of insured mail, 1965-1966, and a cash book, 1895-1900 compiled in August 1901 from membership dues receipts, check book stubs, receipted bills and reports to trustees, are also included.

Series VII. Annual Reports, 1895-1927

The series includes published annual reports, 1896-1925; typescript annual reports, 1926-1927. The report form 1922 is missing. More annual reports can be found scattered throughout the collection. At the front of the first volume is material from 1895 including a memorial to the New York State legislature from the Society's trustees; act of incorporation; by-laws; minutes of an April 6, 1895 meeting at which the first president, Andrew H. Green, and officers were elected.

Robert Moses, as President of the Long Island Park Commission, was chairman of the Council during the period of these records.

Included are minutes, with related correspondence (including letters to and from Moses), reports, New York State legislative documents, clippings, accounts, and printed material.
