Biographical note

The Lee Lash Studios were opened in San Francisco in 1892 by Lee Lash and his brother, Samuel Lash. In 1893, the brothers moved their theatrical curtain company to Philadelphia, and in 1898 to New York City--first at Thirtieth Street and Broadway, later changing locations several times over several decades.

By 1910, they had built a studio for the painting of their theater curtains at Mount Vernon, N.Y. The firm also designed theatrical productions and constructed those designed by others. Lee Lash retired after the stock market crash in 1929 and had a one-man show of his paintings in 1935 in New York City. Harry J. Kuckuck, who had joined the company in 1892, had owned the studio for twenty years at the time of his death in 1945.

Scope and content note

Includes ca. 381 original designs for curtains, drops, olios, nightclubs, several set designs, parts of several set models, and ca. 185 photographs of the Lee Lash Studios designs. There is also a 1912 catalog of the company's work, and a German language publication, possibly used for design ideas. Most designs are color on paper or board and are unidentified, although many are numbered. Two of the set designs are for the play *Bet Your Life* by Fritz Blocki and Willie Howard (John Golden Theatre, 1937), and for the motion picture *Everybody's Girl*, ca. 1918. Some designs are signed by Victor Graziano and Charles Moore Smith. There are also a small number of pencil sketches; some are of circus characters.

Many of the designs are stamped "Lee Lash Studios," "Stagecraft Studios" and "H.J. Kuckuck's Lee-Lash Studios" (or "H.J. Kuckuck's Lee Lash Studios"). There are also black and white and hand-colored photographs of the firm's work. A number of the designs have the United Scenic Artists seal stamped on the versos.

Many of the designs are in fragile condition.
